A LATE SPRING JAUNT TO THE SCENIC HUDSON VALLEY

The Hudson River valley is one of the most beautiful areas in the northeast. Explored by Henry Hudson, along the river that bears his name, the pre-revolutionary towns and breathtaking views of the Catskills (and, on a clear day, maybe even the Berkshires) make this trip a highlight of the PAOP year. Home of artists, authors, and presidents, the Hudson valley forms a perfect trail through the political and cultural history of early America.

This month, the flyout is scheduled to avoid the Memorial Day weekend. It's also on a Saturday, so we can include some of those folks who have other obligations on Sundays.

On May 20, we'll fly for brunch amid this splendor, at the Tail Winds Café (yes, they spell it with two words) at Sky Acres airport (44N), in Millbrook, NY. With the restaurant and pilot shop housed in a converted dairy barn, the country ambience will be complete. Be aware that Tail Winds does not accept credit cards.

Cash and personal checks are the only forms of payment accepted.

It's just 121 nm across some of the most scenic country in the northeast. Be sure to establish communications with the tower at Dutchess County Airport at Poughkeepsie (KPOU), as your approach to Sky Acres goes through their Class D airspace. Our destination is just a few miles east northeast of KPOU, and 5 nm on the 068 radial of Kingston VOR (IGN). There is self-service fuel available.

You may want to plan your return trip to include a flight down the Hudson and through the corridor along Manhattan. Just be sure to have a current New York Terminal Chart and take the free online FAA course on operations in the Hudson River Exclusion. Procedures are simple, but deviation can be costly.

We'll gather at Penn Airways at 0930 for 1000 takeoff. Take a non-pilot or a student along, for an introduction to the world of general aviation—the fun and camaraderie. Contact Tim Drager (484-999-0060 or tdrager@yahoo.com) and let him know if you'll need a ride or have a seat available in your plane.



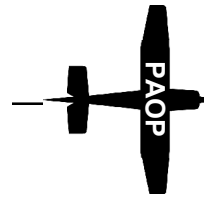

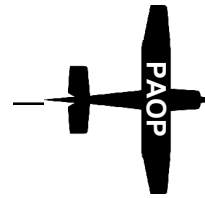

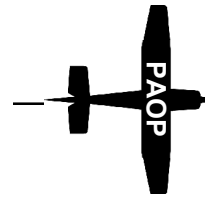

From Mike

In dry air at 20 °C (68 °F), the **speed of sound** is 343 metres per second (1,125 ft/s; 1,235 km/h; 767 mph; 667 kn), or a kilometre in 2.91 s or a mile in 4.69 s. The distance between Chester County Airport and Heritage Field is 24 statute miles. Therefore a sound would travel between the two airports on a dry day at 68 degrees in 1.87 minutes.

It normally takes around twenty minutes for me to fly the partnership PA28-181 from KMQS (Chester County) to KPTW (Heritage Field). So the sound would beat me back by about eighteen minutes.

Recently, I attended the Cheesesteak Dinner held by PAOP at the Pottstown Municipal Airport. I was told the cheesesteaks were good, which makes me feel good since I was the sandwich chef.

While enjoying the dinner and the good company, I heard it discussed that the new

FBO management company, Signature Aviation, at KMQS was charging general aviation aircraft a landing fee and a tie down fee. This is typical at really large and busy airports, but not usually at local airports. Some airports that have a fee will waive them if you buy aviation fuel or dine in their restaurant or café. It was told that neither waiver was the case at Chester County.

Most GA pilots will not come back to an airport if they fly there to have breakfast or lunch and then have to pay a fee to the airport on top of that. SO, the information spread among the pilots at the dinner, and I am sure the little café at kmqs lost some business.

I called Signature at Chester County and was told that while they tried to impose such fees when they first took over, that it is not now the practice, as they want the general aviation community to come in, use their facilities and dine at the Café. I also reached out to Signature Corporate offices by email, but at the time of this writing have not had a response.

So, whether it is a rumor, or truth, the sound of one pilots voice at a dinner can travel fast within the general aviation community. Here are some facts: The café is open for business, and the airport operator is not going to charge you a tie down or landing fee if you are a paying customer at the Café.

When you have your coffee or lunch there the next time: Tell them 'Sky-hawk sent you'.

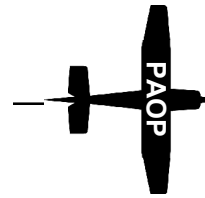

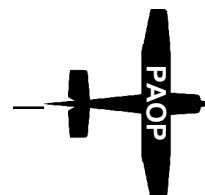
