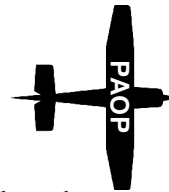

### Leaf-peeping in the Catskills

Nestled near the foothills of the Catskills, Orange County Airport (KMGJ), Montgomery, NY, features spacious runways in a delightful setting, with the newly opened Friendly Skies Airport Café to be our brunch venue. Our October 28 flyout should be prime for aerial leaf-peeping, as we wend our way over the ridges and forests of north Jersey lake country and into the cooler climate of New York State. It's a scenic 96 nm, with no need to deal with either Allentown (the route gets close) or New York airspace.

Orange County has been a favorite destination in the past, but the cozy restaurant had closed a while back. Early this year, a new operator took over, and they have had some good reviews on various web sites. Breakfast is available until the 3 PM closing. It's also a perfect opportunity to practice some instrument approaches, with six approaches, including ILS, VOR, and RNAV/GPS.

We'll gather at Penn Airways at 1000 for 1030 takeoff. Bring a friend or bring a student pilot (or bring a friend who is a student pilot). Contact Gene Poppel at 610-647-1332 or [genepoppel@comcast.net](mailto:genepoppel@comcast.net) if you

want a ride or have an available seat in your plane. These flights can be used to give student pilots a chance to plan and follow a cross-country flight, without having to simultaneously fly the plane—a good step in their training.

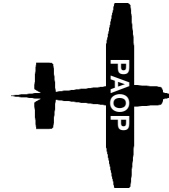

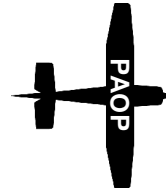
